WHEREAS, on the 17th day of May, 1971, the said Board of Supervisors set June 7, 1971, at 11 o'clock A. M., in the office of the Board of Supervisors of Cochise County, Arizona, at the Cochise County Courthouse at Bisbee, Arizona, as the time and place for a hearing on said petition, and directed that notice of hearing thereof should be both posted and published as required and as permitted by Section 36-1304 of the Arizona Pevised Statutes annotated, as amended, and further directed that notice of said hearing be given by mail to the State Board of Health; and further fixed the bond of the petitioners in the amount of \$300.00, which bond was then posted and approved, and

WHEREAS, on the 7th day of June, 1971, at the hour of 11 o'clock A. P. in the office of the Board of Supervisors of Cochise County, Arizona, at the Cochise County Courthouse, at Pishee Arizona, a hearing was held by said Board of Supervisors on said petition, and

VHEREAS, at said hearing evidence was presented in support of said petition and all the statements and allegations therein contained, and

WHEREAS, it appears to the Board of Supervisors of Cochise County, Arizona, and the Board finds, that said cetition is in all respects regular and fully complies with Section 36-1301 through Section 36-1329 of the Arizona Revised Statutes annotated, as amended; that due and

legal notice of the hearing of said petition was given for the time and in the manner provided by law; that notice of said hearing and stating the boundaries of the proposed district was published twice in a newspaper of general circulation within the proposed district, which publications were one week apart and the first of which was more than ten days prior to the date of said hearing; that more than ten days prior to said hearing the State Board of Health was notified by mail of the time, place and purpose of said hearing; that said petition is signed by a majority of the owners of real property within the limits of the proposed Sanitary District; that the work proposed by said petition is a public necessity; that the public health, comfort, convenience, necessity, and welfare will be promoted by the formation and establishment of the proposed district.

### NOW THEREFORE IT IS HEREBY ORDERED:

- That the petition for the formation of said Sanitary District be granted;
- 2. That a Sanitary District containing and comprising the territory and having the boundaries hereinafter set forth is hereby organized, established, and declared to be a body corporate;
- 3. That the name of said Sanitary District shall be "Naco Sanitary District of Cochise County, Arizona";
- 4. That said Sanitary District has an area of greater than 160 acres; and the James Willson, Jack Horan, John Marusich, Rosalie Barboa, and Gene Wiesener, each being a qualified elector in said Sanitary District, are hereby appointed as Directors of said Sanitary District;
- 5. That the said Sanitary District shall contain and comprise the following described property and the boundaries thereof shall be:

Reginning at the Northeast corner of Section 19, Township 24 S, Hange 24 E of the 2 & S R B & M, Cochise County, Arizona, South 821.7 ft. thence West 1308.2 ft. to the point of beginning thence West 5260.27 ft., Forth 3480.7 ft., East 2364.27 ft., South 665.7 ft., East 550.0 ft., South 675.0 ft., East 2346.0 ft., South 2140.0 ft. to point of beginning.
